6b. **Development Initiatives – Plan Baton Rouge Master Plan Phase II** – The Commission viewed, via power point, photographs of downtown projects. North Boulevard Town Square/Riverfront Master Plan – The Commission viewed, via power point, a map indicating the location of the proposed North Blvd. Town Square. Mr. Rhorer introduced Ms. Dana Brown, Brown + Danos, Landscape Architects, project Landscape Architects.

Ms. Brown informed the Commission that Brown + Danos joint ventured with Joey Furr Design Studio for this project. The town square is envisioned to be the center of culture and civic activity in Baton Rouge. The sub-consultants are a diverse and creative team. The contract will be submitted to the Metropolitan Council for approval this afternoon.

Albemarle Headquarters – Mr. Rhorer informed the Commission that Albemarle, a specialty chemicals company, is moving its corporate headquarters from downtown Richmond to Chase Towers, where it already operates its operational headquarters.

One Eleven at the Shaw Center – The Commission viewed, via power point, a rendering of the project and the logo. Each Commissioner received a copy of the flyer and newspaper article. Mr. Rhorer informed the Commission that preleasing for the units have commenced and encouraged everyone to visit the web site at www.cprt.com/oneeleven.

Arts & Entertainment District Update – The Commission viewed, via power point, an aerial photograph of the Council approved Arts & Entertainment District. Each Commissioner received a copy of the previous meeting agenda, correspondence and newspaper article. Mr. Rhorer informed the Commission that the Planning Commission approved to extend the boundaries of the Arts & Entertainment District to include the Old State Capitol, LASM and the levee. It will go before the Zoning Council on June 18 at 4:00 p.m. Mr. Cohoon informed the Commission that the Arts & Entertainment District Committee received the following updates from the subcommittees on May 29.

- Update on the Receptions facilities issue in progress thanked Brace for sharing the contract language from Lyceum Dean
- In the process of hiring a planning consultant to create an economic incentive package for the Arts and Entertainment District. This component will be included in the Plan Baton Rouge Master Plan II. The firms will present their proposals on Monday, June 23 & Tuesday, June 24

- The Downtown Business Association continues to work on developing a partnership with the City Police.
- Negotiations continue with the state in developing the storefront space on Third Street garage to house the downtown police officers and an art gallery. The city is proceeding in securing funds for the project.
- Extended the boundaries of the Arts & Entertainment District to include the LASM Old State Capitol and the levee will be heard by the Metropolitan Council on June 25th.

Also at the May 29th meeting the Arts & Entertainment Committee established the following sub-committees:

The committee will reconvene on July 1, 4:00 p.m. at Chenevert Architects.

Mr. Godfrey expressed his disappoint with an article that was published in 225 magazine. The article relegated the Lyceum to the status of being a reception hall that attracts dangerous large crowds to downtown. Mr. Godfrey read his response "letter to the editor".

Louisiana Association of Broadcasters – The Commission viewed, via power point, a photograph of the expansion project. Mr. Fluhr informed the Commission that Louisiana Association of Broadcasters are expanding their offices by 3,000 sq. ft. The expansion will allow broadcasters in need of emergency space to use the building. The project cost is approximately \$750,000 and is scheduled for completion – fourth quarter of 2008.

Belle of Baton Rouge Garage – The Commission viewed, via power point, a photograph of the neighborhood street name signs. Each Commissioner received a copy of the newspaper article.
