- 1. Mrs. Cheri Ausberry called the meeting to order.
- 2. Mrs. Cheri Ausberry declared a quorum.
- 3. Mr. Norman Chenevert moved to approve the agenda, Ms. Fran Gladden seconded and the agenda was approved.
- 4. Mr. Norman Chenevert moved to approve the March 9, 2010 minutes, Ms. Chris Nichols seconded and the minutes were approved.
- 5. **Board Action** There was no board action.

Mr. Rhorer thanked Ms. Carol Gikas, executive director, for hosting the board meeting. Ms. Gikas welcomed everyone and informed the Commission that the LASM attracts approximately 70,000 visitors a year. LASM was selected to host the International Planetarium Society Conference in 2012. To prepare for the conference the equipment will be upgraded. Mr. Jon Elvert, planetarium director, briefed the Commission on the technology of the planetarium.

The Commission viewed, via PowerPoint, photographs of the past weekend activities downtown. Mr. Rhorer reviewed the events downtown this past weekend.

6a. **Governmental Issues** – **River Park Update** – The Commission viewed, via PowerPoint, photographs of the current construction for the underpass and renderings of the proposed mixed use development. Each Commissioner received a copy of the Senate Bill 611.

Mr. Pete Clements informed the Commission that the underpass construction is 80% complete and the anticipated completion date is November 2010.

A service road that will provide access to the batture property is also being built. A development plan has been created for River Park. Included in the plan is a proposed wharf that will jet out into the river from the north to south ends of River Park, two parking garages, an entertainment district, a hotel district, and a residential district. The four phases of the River Park development are below.

- Phase 1 Underpass
- Phase 2 Entertainment District 2 floors, 33,000 sq. ft. of space for live entertainment, 120, 000 sq. ft for restaurant, shops etc. and other retail options.
- Phase 3 Hotel District Traditional Hotel & Suite Concept
- Phase 4 Residential District 800 1000 units offering ownership and rental Early concept and planning phases

Mr. Mark Drennen, Cornerstone Government Affairs, informed the Commission that the proposed Senate Bill 611 by Senator Dorsey creates an economic development district for the 60 acres. The district will have a board appointed by the Mayor and Metropolitan Council and will have the ability to raise funds by levying a tax within the district. Senate Bill 611 also creates a TIF for the project. The TIF is extremely important, because it will enable the developer to construct the public board walk along the Mississippi River, the key element to bringing all the components together would be a riverfront park.

John Carpenter, Assistant Chief Administrative Officer, expressed that the Mayor's office is in support of the project and encouraged everyone to support the project. Mr. Chenevert encouraged Mr. Clements to continue working towards implementing the residential component of the project. Mr. Norman Chenevert moved that the Downtown Development District support the project in concept and work closely with the developers regarding the taxing district. Ms. Chris Nichols seconded and motion was approved.

Mr. Rhorer commended Mr. Clements on this extraordinary project.

Baton Rouge Fire Department – The Commission viewed, via Power Point, a photograph of the promotional flyer. Fire Chief Ed Smith thanked the DDD for the opportunity to address the Commission regarding the tax renewal for the B.R. Fire Department. Chief Smith introduced Mr. Curt Monte, union president. Mr. Monte expressed that the tax renewal affects 26% of the salaries for the fire fighters. In 1979 the Baton Rouge Fire Dept. was the first in the nation to earn a Class 1 rating, which has been maintained every year since. Mr. Monte encouraged everyone to vote in favor of the tax renewal on May 1, 2010. Mr. Cohoon moved that the DDD go on record endorsing the tax election. Ms. Chris Nichols seconded and the motion was approved.

**6b. Development Initiatives** – **Mentorship Academy**– The Commission viewed, via Power Point, a photograph of the logo for the Mentorship Academy. Mr. Brian Dixon, executive director, informed the Commission that the Mentorship Academy is two schools; one is focused on Science and Technology and the other focused on Digital Arts. The school will be located in the Regions Bank building on the corner of Florida and Fourth Street.

Mentorship Academy is a public school and is open to all incoming 9<sup>th</sup> graders. Mr. Dixon encouraged everyone to volunteer to be a mentor.

**Downtown Greenway** – The Commission viewed, via Power Point, the proposed greenway route and phases of the project. The Downtown Development District is working with ABMB Engineers to produce the feasibility study and cost estimates for the proposed greenway. Mr. Laurence Lambert, ABMB, informed the Commission that the proposed downtown Greenway is a three mile connecter that will serve as a multi use path that includes walking and biking and could connect seven BREC parks. The minimum cost is \$2.75 million up to \$12 million. Mr. Lambert briefed the Commission on the following proposed phases.

- Phase One BREC's City Park to Expressway Park
- Phase Two Continue from Expressway Park along South 10<sup>th</sup> Street across Government and ending at North Blvd.
- Phase Three Continue along North Blvd. median and turn north onto North 7<sup>th</sup> through Spanish Town and end at Arsenal Park and Capitol Lakes.
- Phase Four Connect Arsenal Park and Capitol Lakes with Memorial Stadium.

Mr. Rhorer informed the Commission that there are funds in the Downtown Visitors' Amenity Plan account designated for improvements under Interstate-110. The DDD will be applying for grants through Federal Department of Housing and Urban Development, the State Department of Culture, Recreation & Tourism. Mr. Rhorer also informed the Commission that the Downtown Greenway is to be included in Metropolitan Planning Organization's Transportation Improvement Plan. Mr. Rhorer thanked the Baton Rouge Advocates for Safe Streets (BRASS) group for their recent support of the proposed greenway by riding the proposed route.

**Police Substation** – The Commission viewed, via Power Point, proposed renderings for the build out of the substation. Mr. John Carpenter, Assistant Chief Administrative Officer, informed the Commission that the city and the state have reached an agreement on the lease. The agreement will be taken to the office of Facility Corporation for final approval. The space should be complete by January 2011. Mr. Norman Chenevert, architect, reviewed the proposed plans for the space.

**North Blvd. Over Pass** – The Commission viewed, via Power Point, a photograph of the North Blvd. overpass. Mr. Rhorer informed the Commission that the Metropolitan Council approved \$200,000 to install railing on the overpass for bicyclist and walkers. This will allow a direct connection from downtown to the Baton Rouge Community College.

**Beauregard Town Community Garden** – The Commission viewed, via Power Point, a photograph of the plans for the garden and volunteers working in the community garden. Mr. Brian Goad, president of Beauregard Town Civic Association (BTCA), announced that BTCA has partnered with First United Methodist Church to implement a community garden in Beauregard Town. This is the first organic garden in the City of Baton Rouge.

Rev. Chris Andrews thanked Ms. Chris Nichols for her assistance with this project and the Pettit family for their donation of the land to develop the garden. Ms. Chris Nichols expressed her excitement with the development of the garden.

**CATS** – The Commission viewed, via Power Point, a photograph of the CATS shuttle and logo. Mr. Brian Marshall, president, informed the Commission that CATS implemented the shuttle express service for the April 16<sup>th</sup> Live After Five concert with 89% on time performance. CATS also offered a comfort bus for anyone to relax and cool off during the concert. Mr. Marshall announced that in concert with US Air, CATS will implement a shuttle service from downtown to the airport, as well as service to and from Corporate Blvd. and the airport. This service is expected to start May 2010.

**Spanish Town Parking Permit Ordinance** — The Commission viewed, via PowerPoint, a photograph of the parking permit signage. Councilwoman Tara Wicker informed the Commission that on Wednesday, April 14, the Metropolitan Council will hear the amendments to the parking permit program in Spanish Town. The ordinance was proposed to enhance the quality of life for the Spanish Town community. Mr. Rhorer thanked Councilwoman Wicker for her assistance with the program.
