1. Mr. Scott Hensgens called the meeting to order.

2. Mr. Scott Hensgens declared a quorum.

**3**. Mrs. Fran Gladden moved to approve the agenda, Mrs. Melanie Montanaro seconded and the agenda was approved.

**4**. Ms. Cheryl McCormick moved to approve the May 9, 2017 minutes, Mrs. Melanie Montanaro seconded and the minutes were approved.

Mr. Hensgens recognized Mrs. Carol Gikas and thanked her for hosting the Commission meeting. Mrs. Gikas welcomed everyone to LASM and briefed everyone on the exhibit "Faces of the Flood". Mr. Keith Dixon briefed the Commission on upcoming events and encouraged everyone to visit the website at <u>www.lasm.org</u>.

5. Board Action – There was no board action.

6. Governmental Issues – There was no information to report.

7. Update from Previous Board Meeting – Trolley Tour – The Commission viewed, via PowerPoint, images of the trolley tour. Each Commissioner received a copy of the newspaper article. Mr. Rhorer briefed the Commission on the trolley tour, highlighting the construction projects and issues in the Downtown East area. He noted issues pertaining to homelessness and suggested establishing a committee to address the issue. Additional funds have been received for the Road Home Program to help reconnect the homeless with their families.

**DDD 30 Year Anniversary** – The Commission viewed, via PowerPoint, an image of the 30 year logo. Each Commissioner received the listing of upcoming and completed downtown projects for 2017 / 2018. Mr. Rhorer informed the Commission that the DDD will celebrate their 30 year anniversary. The DDD will be highlighting 12 major projects over the course of the next year and plans are to have an outdoor celebration in March 2018. Mr. Rhorer commended Mr. Gabe Vicknair for designing the logo.

**Cristo Rey** – The Commission viewed, via PowerPoint, a photograph of the school and students. Mr. Brian Moscona, serves as the President of the Baton Rouge Franciscan High School "Cristo Rey". This model partners with the business community which allows the students to spend five days of the month interning in the business community. The school was affected by the 2016 flood and has been housed in Bon Carre but will be returning to the Redemptorist campus after Labor Day. Mr. Moscona thanked everyone for their support and encouraged anyone interested in participating in the program to contact him following the meeting.

**CATS Touchdown Express** – The Commission viewed, via PowerPoint, a photograph of the CATS bus. Each Commissioner received a copy of the press release and newspaper article Mr. Theo Richards, CATS, informed the Commission that Touchdown Express will resume for the 2017 LSU football season. Touchdown Express will have four pick up points downtown and the service begins three hours before kickoff and immediately following the game. **Terrace Street Ramp** – The Commission viewed, via PowerPoint, images of the proposed Interstate improvements. Ms. Anna Hanks, DOTD, informed the Commission that the design work for the proposed exit at I-110 southbound at Terrace is 95% complete. The design is being funded by state transportation dollars and construction is funded by federal dollars. The project is expected to go out to bid early 2018. Construction is projected to commence spring 2018 with an 18 – 24 month construction period. **Government Street Improvements** – Ms. Hanks informed the Commission that the final plans have been received and are under final review. The project is expected to go out to bid early fall 2017. Construction will commence 2018 with an 18 - 24 month construction period.

**Baton Rouge Film Commission** – The Commission viewed, via PowerPoint, an image of the logo. Ms. Katie Pryor, Executive Director, briefed the Commission on the responsibilities of the Baton Rouge Film Commission. They work closely with the DDD in regards to street closures and are anticipating more business in October 2017.

**Downtown Greenway** – The Commission viewed, via PowerPoint, photographs of the greenway. Mr. Vicknair informed the Commission that the North Blvd. portion of the greenway is complete. Final plans for the East Blvd. portion of the Downtown Greenway are expected in approximately two weeks.

**North Blvd. Town Square Phase II** – The Commission viewed, via PowerPoint, a rendered image of the proposed improvements. Mr. Vicknair informed the Commission the project is expected to be bid out in August 2017 with three months to award contract.

**City Hall Plaza** – The Commission viewed, via PowerPoint, a rendering of the proposed improvements and photographs of current construction. Mr. Vicknair briefed the Commission on the current construction of the plaza. The project is proposed to be complete the first quarter of 2018.

**Riverfront Plaza** – The Commission viewed, via PowerPoint, a rendering of the proposed improvements. Each Commissioner received a copy of the newspaper article. The overall design and project will be implemented in several states. There is currently a land survey underway and the designers are looking at what to include in Phase I. Mr. Rhorer informed the Commission that upgrades will include lighting and a sound system.

**Downtown Maintenance Committee** – The Commission viewed, via PowerPoint, a photograph of Magpie Café and Denicola's & Noelie Harmon. Mrs. Whitney Sayal informed the Commission that the committee is reviewing and drafting ordinances relating to utility paint markings and waste collection. The committee is also working with the Planning Commission to update the UDC overlay district. The winners of the June and July Downtown Distinction Award are as follows:
