6a. Governmental Issues – Riverfront Development – The Commission viewed, via PowerPoint, an image of proposed rendering for intersection improvements. Mr. Davis Rhorer informed the Commission that the Metropolitan Council approved the TCSP funding for the improvements to the intersection of Florida and River Road as well as a walkway and plaza improvement at the LASM. Bids will be going out late August with construction commencing fall 2012.

Mr. Rhorer informed the Commission that Mayor Holden is proposing a budget supplement that will go before the Metropolitan Council Wednesday, June 26, 2012. Following are items for downtown include:

- Signage for North Blvd. Town Square
- Lighting for Galvez Plaza stage canopy
- Lafayette Street pedestrian improvements
- Riverfront gateway enhancements

Mr. Van Mayhall expressed that the budget supplement includes a number of items regarding public safety and encouraged everyone to support the budget supplement.

2010 FHWA Recreational Trails Grant – The Commission viewed, via PowerPoint, an image of proposed rendering for trails. Mr. Gabe Vicknair informed the Commission that the grant was approved by the Metropolitan Council.

River Center Library – The Commission viewed, via PowerPoint, an image of the River Center library. Ms. Alice Cooper, River Center branch manager, informed the Commission that the Metropolitan Council has approved the contract with the architect. Ms. Cooper expressed her excitement to move onto the design phase of the project. Mr. Rex Cabaniss, WHLC architecture, commended everyone for their support of the project.
