1. Mrs. Fran Gladden called the meeting to order.

2. Mrs. Fran Gladden declared a quorum.

3. Mrs. Melanie Montanaro moved to approve the agenda, Mr. Scott Hensgens seconded and the agenda was approved.

4. Mrs. Melanie Montanaro moved to approve the February 11, 2016 minutes, Ms. Cheryl McCormick seconded and the minutes were approved.

Mrs. Fran Gladden thanked St. James for hosting the meeting. Ms. Lauren Ray, head of St. James Day school, welcomed everyone and briefed them on the history of the school. Ms. Ray invited everyone to stay after the meeting for a tour of the school.

5. Board Action – There was no board action.

6a. Governmental Issues – There was no information.

6b. Development Initiatives – **Downtown East Developments** – The Commission viewed, via PowerPoint, an image of the development map and photographs of the developments. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer briefed the Commission on the following projects proposed for downtown:

- **Sports Academy** No update to report
- **Deville Apartments** No update to report
- Elysian II The Planning Commission approved the proposed expansion.

- Louisiana Avenue Connector Schematics will be presented at the April DDD board meeting.

Lofts @ **6C** – The Commission viewed, via PowerPoint, images of the proposed development. Mr. John O. Hearin, developer, thanked the DDD and everyone involved in the project and informed the Commission that the project was approved by the Planning Commission on February 15, 2016. Mr. Hearin briefed the Commission on the proposed mixed use development located on the corner of Florida and Sixth Streets and Convention and Sixth Streets. The six story development will include the following:

- 142 residential units 58 one bedroom units and 94 two bedroom units
- Pool
- Clubhouse
- Rooftop courtyard
- Rooftop garden
- Greenspace

The first two floors will be parking with retail available on the first floor. Once HUD signs off on the project construction is expected to commence in 30 - 45 days with a construction period of 18 months.

Parking Implementation Strategy – The Commission viewed, via PowerPoint, images of the parking strategy. Mr. Rhorer informed the Commission that as a result of the Parking Implementation Strategy by Fregonese Associates, a committee will be formed to discuss how to implement the plan. Mr. Rhorer briefed the Commission on the following recommendations of the plan:

- Update to modern meters
- Management of the garages
- Parking Guidance
- Garage Expansion

Mr. Fregonese will meet with the committee Friday, April 1, 2016.

Downtown Library – The Commission viewed, via PowerPoint, images of proposed renderings of the library. Each Commissioner received a copy of the newspaper article. Mr. Rhorer informed the Commission that the Metropolitan Council approved the lease agreement for the Kress Building as the temporary space for the library. The library will begin their move six weeks after the City Parish approves the contract.

Public Hearings – **I-10 Meetings** – The Commission viewed, via PowerPoint, a photograph of public meeting and image of the proposed improvements. Each Commissioner received a copy of the newspaper article. Mr. Rhorer informed the Commission that the public meeting scheduled for Tuesday, February 23 has been re-scheduled for Wednesday, March 9 at the Addis Community Center. Everyone was encouraged to stay informed by visiting <u>www.i10br.com</u>.

TRAM – The Commission viewed, via PowerPoint, a photograph of public meeting and images of the proposed routes. Each Commissioner received a copy of the newspaper article. Mr. Rhorer informed the Commission that City Parish selected Route Option 2 for the proposed tram which would be a direct link between Tiger Stadium and the State Capitol. North and southbound trams would run on Nicholson Drive, St. Ferdinand Street and North Fourth Street between South Stadium Drive and North Street. The proposed route is a straight shot to and from downtown and is easy walking distance from downtown attractions. The proposed hours for the tram are 6:00 a.m. – 10:00 p.m. weekdays and hours will be extended during the weekend. Mr. Rhorer commended the Mayor for his support on this project.

Downtown Greenway – The Commission viewed, via PowerPoint, renderings of the proposed greenway. Each Commissioner received a copy of the newspaper article. Ms. Whitney Cooper informed the Commission that the Environmental Clearance process for the North Blvd portion of the Greenway is being finalized. Solicitation of view letters have been sent to difference agencies for their comments. Final responses are due by Friday, April 1 with construction expected to commence in May 2016. T. J. Jemison and East Blvd. portion is under 95% review with DOTD and the state historic preservation office.

River Road – Great Places of Louisiana Award – The Commission viewed, via PowerPoint, a photograph of DDD staff receiving the award. Each Commissioner received a copy of the press release. Ms. Cooper informed the Commission that the DDD and the City Parish were awarded the "Great Places of Louisiana" award for the transformation of River Rd. into a 'complete street' from the Louisiana Chapter of the American Planning Association.

Downtown Bike Racks – The Commission viewed, via PowerPoint, a photograph of the proposed bike racks. Ms. Whitney Cooper informed the Commission that the DDD / City Parish received a grant from Congestion Mitigation & Air Quality program in partnership with CRPC. The majority of the bike racks have been installed on Third Street and those proposed locations on the riverfront are waiting on approval from the Corps of Engineers for installation.

Downtown Bike Share – The Commission viewed, via PowerPoint, a photograph of the bike share station in Birmingham, Alabama. Ms. Cooper informed the Commission that February 28 & 29, 2016 representatives from the DDD, BRAF, LSU, BREC, CPEX and CRPC participated in a site visit to Birmingham, Alabama to learn about their successful "ZYP" bike share program. The team learned a lot about the successful program and will reconvene Wednesday, March 16, 2016 to debrief and discuss next steps.

Downtown Maintenance Committee – The Commission viewed, via PowerPoint, a photograph of a street sweeper. Ms. Whitney Cooper informed the Commission the subcommittees will meet the following dates:
