**6a. Governmental Issues** – **CATS Update** – The Commission viewed, via PowerPoint, an image of CATS logo and listing of downtown improvements. Mr. Brian Marshall thanked everyone who supported the tax, but expressed that the system has a deficit for the remainder of 2012.

Larger idea of the plan is linking the city together. Public transportation ties together land use. Changes will begin in 2013 with the purchase of a variety of vehicles followed by the real roll out in 2014. CATS will continue to meet with the public and provide updates on its progress.

Mr. Rhorer informed the Commission that DDD has been working with CATS and identified approximately 400 parking spaces under the Interstates downtown and will explore transportation from the sites to downtown locations.

Mr. Rhorer briefed the Commission on the following Governmental issues:

- SCR 62 Resolution concerning the site of the Old Insurance Building which is adjacent to the State Capitol and Spanish Town neighborhood. The legislative auditors has expressed interested in the site. The DDD will continue to monitor the resolution.
- The Metropolitan Council will consider the contract for hiring the architect for the downtown library on Wednesday, May 9, 2012.

**Riverfront Development** – The Commission viewed, via PowerPoint, an image of the proposed River Rd. & Florida Street improvements. Mr. Rhorer reported that funding is in place for improvements to the Florida Street and River Road improvements. DDD is working with DPW on the construction plans. The project will go out to bid in August 2012 and construction will commence in the fall 2012

**Docking Facility** – The Commission viewed, via PowerPoint, a photograph of the riverfront dock and proposed sail shades. Mr. Rhorer informed the Commission that the American Queen will be arriving at the dock on May 20, 2012. The dock has been painted and sail shades are proposed for the facility. Ms. Katie Guasco, Visit Baton Rouge, announced the 2012 dock dates for the four leisure cruise ships coming to Baton Rouge. Visit Baton Rouge mobile information center will be on the dock to welcome guests to Baton Rouge. Ms. Guasco encouraged everyone to obtain welcome buttons and signs to display in their business.

**6b.** Development Initiatives – North Boulevard Town Square Update (NBTS) – The Commission viewed, via PowerPoint, photograph of the Ribbon Cutting ceremony and Live After Five concert. Mr. Gabe Vicknair informed the Commission that NBTS officially kicked off with the April 10<sup>th</sup> ribbon cutting ceremony. Downtown Development District will be working closely with the upcoming events held at the NBTS.

**Repentance Park Update**— The Commission viewed, via PowerPoint, a photograph of the current construction site. Mr. Vicknair informed the Commission that underground construction continues and he and Mr. Rhorer will be viewing mock up of ornamental metals and other site materials.

**Baton Rouge Wall Project** – The Commission viewed, via PowerPoint, a photograph of the web page. Mr. Casey Phillips announced that the project received the funding and is now reaching out to private business community for matching funds to bring the project to fruition. The first building mural will begin on June 15, 2012. Mr. Phillips thanked the sponsors and Vision City for providing them with office space for their headquarters. Mr. Robert Dafford, muralist, briefed the Commission on his experience with mural projects and expressed that the murals created will attract visitors to the downtown area. **Tessier Building Update** – The Commission viewed, via PowerPoint, photographs of current construction site, interior of the units and proposed rendering of Lafayette House. Mr. David Weinstein informed the Commission that he and business partner Mr. Dyke Nelson began renovating the Tessier Building over one year ago and now are in the final phase of the renovation. Of the 9,850 sq. ft., the building currently has 3,000 sq. ft available for lease. Mr. Dyke Nelson informed the Commission that based on the success of the three residential units in the Tessier Building, they decided to develop a four story 16 apartment unit "Lafayette House" on the remaining property. Lafayette House will be one bedrooms with courtyards and balconies. The units are for sale and anyone interested can contact Mr. Nelson or Mr. Weinstein.

**Residential Development** – **438 Main Street** – The Commission viewed, via PowerPoint, an image of the rendering. Ms. Helena Cunningham, developer of 438 Main St., informed the Commission that the 22 unit affordable housing rental development is currently 56 % complete. Completion date is scheduled for September 2012. The have over forty inquiries on the interest list and leasing for the units will begin within 30-45 days.
