- 1. Mr. Scott Hensgens called the meeting to order.
- **2.** Mr. Scott Hensgens declared a quorum.
- **3**. Ms. Cheryl McCormick moved to approve the agenda, Mr. Rhorer requested the following be added to the agenda "637 St. Ferdinand" Mr. Eric Dexter seconded and the agenda was approved as amended.
- **4**. Mrs. Melanie Montanaro moved to approve the April 10, 2018 minutes, Mr. Eric Dexter seconded and the minutes were approved.

Mr. Scott Hensgens thanked The Lyceum for hosting the meeting. Ms. Brinkley Maginnis, Director of Sales for The Lyceum Historic Meeting & Events Center welcomed everyone to the space. Ms. Maginnis encouraged anyone interested in the event space to contact her after the meeting.

- 5. Board Action There was no board action.
- **6. Governmental Issues Riverfront Gaming** The Commission viewed, via PowerPoint, a rendering of potential improvements to the Belle of Baton Rouge Casino. Mr. Rhorer informed the Commission that the city is watching the course of Senate Bill #316. The bill would allow landside gambling for riverboats. The Belle of Baton Rouge would utilize the Belle of Baton Rouge atrium for the casino area.

Utility Paint Ordinance – The Commission viewed, via PowerPoint, a photograph of utility markings downtown. Each Commissioner received a copy of the draft ordinance. Mrs. Whitney Sayal briefed the Commission on the issues regarding the utility paint. The maintenance committee drafted an ordinance that requires utility companies use water based paint for marking utilities.

Mrs. Sayal requested that the DDD Commission review the draft ordinance and send any comments to the DDD office. Once approved by DDD Commission, it will be introduced to the Metropolitan Council.

Opportunity Zones – The Commission viewed, via PowerPoint, an image of the Opportunity zones boundary map. Mr. Gabe Vicknair briefed the Commission on the Opportunity Zones tax incentive program that if approved, will be available for downtown.

- The census tracks that make up downtown are now designated as opportunity zones.
- Opportunity zones were added to the tax code by the tax cuts and jobs act late last year.
- The zones were recommended by the state to the US treasury and have since been certified. These zones are economic development tools to spur economic development and job creation in distressed communities.
- The zones spur economic development by providing tax benefits to investors. Prior gains taxes can be deferred if reinvested in the opportunity zone and if the investment is held for at least 10 years.

Mrs. Melanie Montanaro, resident of Beauregard Town, informed the Commission that Beauregard Town Civic Association (BTCA) is opposing the proposed demolition and requested that the DDD Commission support BTCA's position. Mr. Rhorer recommended reaching out to the buyer and requesting a deferral to the Planning Commission.

The space has been a huge economic impact for the city with community events.

Mr. Rhorer informed the Commission that the State in conjunction with BREC, BRAF and LA DOTD are initiating a Comprehensive Pedestrian and Bike Master Plan. City Hall Plaza – The Commission viewed, via PowerPoint, a rendering of the proposed improvements and photographs of current construction. Each Commissioner received a copy of the newspaper article. Mr. Rhorer briefed the Commission on the ribbon cutting for City Hall Plaza, now officially open. The public green space is a major component of PBR II and great location for activities and events.

Riverfront Plaza – The Commission viewed, via PowerPoint, a rendering of the proposed improvements. Mr. Vicknair informed the Commission that bids are under review.

Town Square Phase II – The Commission viewed, via PowerPoint, a rendered image of the proposed improvements. Mr. Rhorer informed the Commission that the improvements are designed for pedestrians the City-Parish is in the process of finalizing the construction contract.
