- 1. Mr. Norman Chenevert called the meeting to order.
- **2.** Mr. Norman Chenevert declared a quorum.
- **3**. Ms. Chris Nichols moved to approve the agenda, Mr. Ric Kearny seconded and the agenda was approved.
- **4**. Ms. Chris Nichols moved to approve the March 11, 2014 and April 8, 2014 minutes, Mr. Ric Kearny seconded and the minutes were approved.
- Mr. Rhorer requested that everyone take a moment to remember Mr. Francis Grayson who passed away recently. Mr. Gayle Carnahan welcomed everyone to the Lyceum Ballroom
- Mr. Norman Chenevert welcomed Mr. Scott Hensgens to the DDD board. Mr. Hensgens expressed his excitement to be a part of the development downtown.
- 5. Board Action There was no board action.

**6a.** Governmental Issues – Old LNB Building Redevelopment District – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Each Commission received a copy of the senate bill and newspaper articles. Mr. Rhorer informed the Commission that the property at 150 Third Street (old LNB Building) was acquired by Mr. Mike Wampold. Mr. Wampold plans to renovate the building into a 146 room hotel. The TIF legislation passed in the Senate and will go before the House for approval. The KPMG study recommended that there be at least 1,000 hotel rooms within walking distance from the River Center and with the completion of this hotel it would bring downtown over this recommended amount.

**Skating / Biking Ordinance** – The Commission viewed, via PowerPoint, a photograph of the scratched benches and benches with skate deterrents. Each Commission received a copy of the new ordinance and newspaper article. Mr. Rhorer informed the Commission that the proposed amendments to the existing ordinance were approved by the Metropolitan Council. DPW will install signage in Town Square.

**6b. Development Initiatives** – **Riverfront Plaza Improvements** – The Commission viewed, via PowerPoint, photographs of kiosks and improvements. Each Commission received a copy of the newspaper article. Mr. Rhorer informed the Commission that the CATS transit hub will relocate to River Road when there are events in North Blvd. Town Square. The Downtown Development District (DDD) has been working with Department of Public Works (DPW) to improve the riverfront and the kiosk. Mr. Rhorer commended the DDD staff and DPW for their work on this project.

**Parking Meter Upgrade** – The Commission viewed, via PowerPoint, a photograph of the existing parking meter and proposed parking meter. Mr. Rhorer informed the Commission that the city is working on upgrading the parking meters downtown and is in the process of reviewing the vendors. **River Road Upgrade** – The Commission viewed, via PowerPoint, the rendering of proposed changes. Mr. Laurence Lambert, Stantec, informed the Commission that as part of the "Right Sizing" program DOTD will convert River Road from Florida Street north to Hollywood Casino from 4 lanes to 3 lanes with a bike path. This conversion will further activate the existing and upcoming trail heads to the levee. It is expected to be completed by spring 2015.

**Downtown Civic Association** – The Commission viewed, via PowerPoint, a photograph of the first Downtown Civic Association membership drive. Ms. Courtney Hunt informed the Commission that the Downtown Civic Association was established April 2014 and currently has 25 members from the Central Business District (CBD). There are currently 80 residential units in the CBD and the association will address issues such as safety, parking etc. and plan to combine efforts with Beauregard Town and Spanish Town Civic Associations.

**310** Convention Street – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Each Commission received a copy of the newspaper articles. Mr. Norman Chenevert briefed the Commission on the history of the house at 310 Convention St. and introduced Mr. Mark Hudson who recently purchased the house.

Mr. Hudson informed the Commission that Phase I will convert the residence into 7 apartments and Phase II will include 6 additional units. Construction is expected to commence June 2014 and will be named "The Grand Lady".

City Hall Plaza – The Commission viewed, via PowerPoint, an image of the proposed improvements. Mr. Rhorer informed the Commission that the selection of Reed Hilderbrand as the design consultants for City Hall Plaza will go before the Metropolitan Council for approval Wednesday, May 14, 2014.

**Underpass Parking** – The Commission viewed, via PowerPoint, a rendering of proposed improvements and map indicating proposed parking. Each Commission received a copy of the newspaper article. Mr. Rhorer informed the Commission that DPW is currently working on the striping between Florida and Laurel St.

**Downtown Greenway Update** – The Commission viewed, via PowerPoint, an image of the proposed renderings. Ms. Whitney Cooper informed the Commission that Phase I bid for Expressway Park has been accepted and bids for Phase II have been received. The BREC Commission will review the Phase II bids for acceptance on May 22, 2014. DOTD is completing their work in the area. Ms. Angela Harms informed the Commission that the Recreation Center offers summer programs. Mr. Rhorer thanked BREC for their commitment to downtown.

**River Road / Riverfront Access Improvements** – The Commission viewed, via PowerPoint, an image of the proposed renderings. Mr. Rhorer informed the Commission that equipment has arrived and once preparation work is completed by Canadian National construction will begin.

**North Blvd. Town Square Phase II** – The Commission viewed, via PowerPoint, images of proposed improvements. Each Commission received a copy of the newspaper article. Mr. Rhorer informed the Commission that Phase II will include improvements one block west of the Old State Capitol, one block east in front of City Plaza building in front of Subway on North Blvd. The designers are making final adjustments and the project will be bid out shortly on the approximately \$2 million project.

**New Business** – **Aristocracy** – The Commission viewed, via PowerPoint, an image of the logo. Mr. Gayle Carnahan announced that Aristocracy has located in the Kress Building and introduced Ms. Kellye Bond. Ms. Bond informed the Commission that Aristocracy specializes in high end menswear, vintage clothing and women's clothing and jewelry. Ms. Bond expressed her excitement to be a part of downtown and encouraged everyone to visit the store Monday through Saturday.

**Raising Cane's** – The Commission viewed, via PowerPoint, an image of the logo. Each Commission received a copy of the newspaper article. Ms. Stormi Persick, general manager, informed the Commission that Raising Cane's is excited to be downtown and the opening will bring an additional 45 jobs. The grand opening is scheduled for Thursday, May 22 at 9:30 a.m.
