- 1. Ms. Chris Nichols called the meeting to order.
- **2.** Ms. Chris Nichols declared a quorum.
- **3**. Mr. Derrell Cohoon moved to approve the agenda, Mrs. Fran Gladden seconded and the agenda was approved.
- **4**. Mr. Van Mayhall, Jr. moved to approve the December 10, 2013 minutes, Mr. Norman Chenevert seconded and the minutes were approved.

Mr. Rhorer thanked Kean Miller for hosting the board meeting.

5. Board Action – **Nominating Committee** – The Commission viewed, via power point, an image of the Nominating Committee. Each Commissioner received a copy of the proposed slate of 2014 officers. Ms. Chris Nichols presented the slate of nominees for the 2014 officers as follows: Norman Chenevert Chairman; Fran Gladden, Vice Chairman; Ric Kearny, Treasurer and, Derrell Cohoon, Secretary. **Mr. Norman Chenvert moved to adopt the nominees as presented, Mr. Van Mayhall, Jr. seconded and the nominees were unanimously approved as presented**.

Mr. Rhorer commended Ms. Chris Nichols for her leadership and commitment to downtown and congratulated Mr. Norman Chenevert on his appointment as chairman.

- **6b. Development Initiatives USS Kidd** The Commission viewed, via PowerPoint, a photograph of the Ms. Alejandra Juan. Mr. Rhorer introduced and welcomed Ms. Alejandra Juan as new director of USS Kidd. Ms. Juan expressed that they will focus more on community involvement and educational outreach and that First Sunday will now include free ship tours. Ms. Juan briefed the Commission on upcoming events planned at the USS Kidd. Mr. Rhorer encouraged everyone to visit the USS Kidd.

Commerce Bldg. – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Mr. Rhorer informed the commission the development is progressing.

440 on Third – The Commission viewed, via PowerPoint, a photograph of the exterior of the building and Matherne's logo. Each Commission received a copy of the newspaper articles. Mr. Rhorer reported that the demolition has begun on the project and the grocery store is projected to be complete by the end of 2014 or first quarter of 2015. Mr. Rhorer commended Mr. Dyke Nelson and Mr. David Weinstein for their commitment to downtown and informed the Commission that Mr. Jonathan Walker is the agent for office space.

New Developments – The Commission viewed, via PowerPoint, images of the proposed renderings. Each Commissioner received a copy of the newspaper article.

Mr. Rhorer informed the Commission that Mrs. Susan Turner and her husband have acquired property and existing houses in Beauregard Town.

Plans are to develop a neighborhood in Beauregard Town "House on the Hill". The development includes 15 residential units and renovation of existing housing. Mr. Susan Turner will attend the February board meeting to give an update.

Grand Lady – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Mr. Rhorer informed the Commission that the old Victorian home on Convention Street will be acquired and will be developed into residential units.

Water Campus – The Commission viewed, via PowerPoint, images of the proposed renderings. Each Commissioner received newspaper articles. Mrs. Tina Rance, Commercial Properties, informed the Commission that a Request for Qualifications will go out for the first building to be constructed on the old City Dock. The building will house the headquarters, discovery center and a model of Mississippi River; it will be an iconic building for Baton Rouge. Discussions continue with agencies to fill the space of the initial phase which will bring approximately 400-500 employees. There will also be a study for a trolley between LSU and water campus. Mr. Rhorer commended everyone involved in the project.

Repentance Park Extension / River Road Improvements – The Commission viewed, via PowerPoint, image of the plan. Mr. Gabe Vicknair informed the Commission that Reed Hilderbrand has been awarded the contract for the Repentance Park Extension. The extension will close the gap between Repentance Park and LASM as well as ease the pedestrian traffic. The project is expected to begin in two weeks and completed by the end of summer 2014.

City Hall Plaza – The Commission viewed, via PowerPoint, an image of the plan. Mr. Gabe Vicknair informed the Commission that the plaza will be converted to green space with shade trees to accommodate events on both sides of Crest. The Request for Qualifications was posted Friday, January 10, 2014. Designer selection will begin in February with a six month design process.

Downtown Greenway Update – The Commission viewed, via PowerPoint, an image of the proposed renderings. Mr. Gabe Vicknair informed the Commission that the Request for Qualifications was posted Friday, January 10, 2014 and the designers will be selected in February. Phase I construction is scheduled to be completed by the end of summer 2014. Expressway Park has partnered with BREC on the \$100,000 Recreational Trails grant which is expected to begin construction in a few months.

Florida / **Riverfront** Access Point – DPW is in the process of coordinating work beginning with the Railroad with construction expected to commence February 2014. Mr. Rhorer acknowledged Mr. Laurence Lambert for his assistance with the various downtown projects.

North Blvd. Town Square Update – The Commission viewed, via PowerPoint, photographs of proposed renderings.

CREST – Mr. Rhorer informed the Commission that Arrighi Construction is working on a punch list for the final details of the CREST. Mr. Rhorer thanked Cox for their contribution to the New Year's Eve event.

Hartley Vey Theatre Entrance – The Commission viewed, via PowerPoint, a photograph of the Hartley Vey Theatre entrance. Mr. Rhorer informed the Commission that the new entrance adjacent to NBTS is complete and they will be having their soft debut this Saturday, January 18, 2014 with a performance by "Moon Honey".

BR Walls Announcement – The Commission viewed, via PowerPoint, an image of the logo and a photograph of the office space. Mr. Casey Phillips informed the Commission that B.R. Walls has found a permanent home in the bottom floor of the Chase South Towers, the space will also include an art gallery. They will be working on interactive cultural community events and are currently beginning a \$1.5 million fundraising for 25 projects. Mr. Phillips thanked everyone for their continued support. Mr. Rhorer will make sure the Cultural products district expansion includes Chase Tower and Main Street Market.
