- **1**. Mr. Norman Chenevert called the meeting to order.
- **2.** Mr. Norman Chenevert declared a quorum.
- **3**. Mr. Derrell Cohoon moved to approve the agenda, Ms. Chris Nichols seconded and the agenda was approved.
- **4**. Mr. Ric Kearny moved to approve the January 14, 2014 minutes, Mrs. Fran Gladden seconded and the minutes were approved.

Pastor Brad Franklin shard a few words of wisdom.

Mr. Rhorer thanked Bill Stark for hosting the board meeting at the museum. Mr. Stark briefed the Commission on the upcoming events, welcomed everyone to the meeting and encouraged them to tour the museum after the meeting.

5. Board Action – There was no board action.

6a. Governmental Issues – Mr. Rhorer informed the Commission that Whitney Cooper has been appointed to the Historic Preservation Commission and that Mr. Rhorer had been appointed to the BREC board.

6b. Development Initiatives – **River District** – The Commission viewed, via PowerPoint, images of proposed renderings. Each Commission received a copy of the newspaper articles. Mr. Rhorer informed the Commission that River District is the proposed 38 acre mixed use development on Nicholson between Magnolia Mound and Red Stick Lofts. The project goes before the Planning Commission in March 2014.

Downtown / LSU Tram – The Commission viewed, via PowerPoint, an aerial indicating a proposed route for the tram and a photograph of a tram. Each Commission received a copy of the newspaper articles. Mr. Rhorer informed the Commission that Future BR proposes the development of a street car along Nicholson corridor to connect downtown to LSU. Mayor Holden is seeking federal funding for the project

Commerce Bldg. – The Commission viewed, via PowerPoint, an image of the proposed rendering of the exterior of the building. Mr. Michael Lang informed the Commission that the project received a commitment for construction financing through HUD 221(d) (4) program; this is the first time a downtown project has received funding through this program. The contracts have been finalized and they have 100% construction documents. The demolition will begin once all financing paper work is completed which is expected to be mid-year of 2014. The proposed 93 residential units will take approximately 12 - 14 months to construct.

Construction Updates – **440 on Third** – The Commission viewed, via PowerPoint, a photograph of the exterior of the building and an image of the proposed rendering of the exterior of the building. Each Commission received a copy of the newspaper articles. Mr. Rhorer reported that construction has begun on the project.

Onyx Bldg. – The Commission viewed, via PowerPoint, a photograph of the construction site and an image of the proposed rendering. Mr. Rhorer informed the Commission that the site has been cleared for construction to begin on the 28 residential units.

IBM – The Commission viewed, via PowerPoint, a photograph of the construction site and an image of the proposed rendering. Mr. Rhorer informed the Commission that the pile driving is complete and construction is progressing.

Richoux's – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Mr. Chris Ferarra, CSRS, informed the Commission that all building permits have been acquired and the demolition has begun. The construction is expected to commence within the next week and is expected to be complete by end of summer 2014.

Holiday Inn Express – The Commission viewed, via PowerPoint, a photograph of the exterior of the building and an image of the proposed rendering. Mr. Rhorer reported that interior demolition has begun on the project.

334 Third Street Development – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Mr. Kerry Denny informed the Commission that he and his wife purchased the building and are in the final stages of the renovation. They will occupy the second floor and the bottom floor has been leased to a French Bistro. Mr. Denny invited everyone to visit their open house which is scheduled Saturday, March 1 during the Spanish Town Mardi Gras parade.

Fresh Junkie – The Commission viewed, via PowerPoint, an image of the logo. Mr. Rhorer informed the Commission that Fresh Junkie will be opening their second downtown location in the 300 block of North Blvd. in approximately two weeks. Mr. Pat Fellows, owner of the restaurant, plans to sponsor fitness activities in North Blvd. Town Square.

House of the Hill – The Commission viewed, via PowerPoint, images of the proposed renderings. Each Commissioner received a copy of the newspaper article. Mrs. Susan Turner informed the Commission that she and her husband purchased the property bordered by Louisiana Ave and Napoleon, St. Joseph and America streets. The proposed development in Beauregard Town "House on the Hill" will include 12 residential units and renovation of existing housing. The residential infill community will include a community garden, community kitchen, gathering space for group meals or meetings. The proposed project will go before the Planning Commission for approval Monday, February 17, 2014. Ms. Chris Nichols moved that the Downtown Development District go on record supporting the development. Mr. Norman Chenevert seconded and the motion was unanimously approved.

I-10 / **I-110** Underpass Improvements – The Commission viewed, via PowerPoint, aerial photographs indicating proposed parking, a photograph of existing parking under the Interstate, and a rendering of proposed improvements. Mr. Rhorer informed the Commission that the DDD has been researching ways to improve under the Interstate 10 / 110. The improvements would include striping, signage and lighting. The DDD will be meeting with DOTD to discuss the improvements and applying for grants.

City Hall Plaza – The Commission viewed, via PowerPoint, an image of the plan. Mr. Rhorer informed the Commission that the City Parish design selection committee will meet this Thursday, February 13, 2014 to select the designer.

Downtown Greenway Update – The Commission viewed, via PowerPoint, an image of the proposed renderings. Each Commission received a copy of the newspaper article.

Ms. Whitney Cooper informed the Commission that BREC continues to work on the Expressway Park recreational center. BREC is accepting bids from contractors for Phase I. BREC is partnering with City Citrus and Baton Rouge Green in planting citrus trees throughout the city. Mr. Rhorer thanked BREC for their commitment to downtown.

North Blvd. Town Square Update – The Commission viewed, via PowerPoint, a photograph of paver repair, benches and APA LA Award. Mr. Gabe Vicknair informed the Commission that the pavers near the Transit Shelter are being repaired and skate deterrent kits are being installed on the benches. Mr. Rhorer informed the Commission that North Blvd. Town Square received the APA Louisiana award and the Crest received the Association of Building Contractors award.

BREC Strategic Planning Meeting – The Commission viewed, via PowerPoint, a photograph of the park activity. Mr. Rhorer encouraged everyone to attend the BREC's Strategic planning meeting scheduled for Tuesday, February 25, 6:00 p.m. to be held at the River Center Library.
