- **2.** Ms. Chris Nichols declared a quorum.
- **3**. Mr. Norman Chenevert moved to approve the agenda, Mr. Van Mayhall seconded and the agenda was approved.
- **4**. Ms. Fran Gladden moved to approve the January 12, 2012 minutes, Mr. Norman Chenevert seconded and the minutes were approved.

Ms. Chris Nichols introduced the newly appointed DDD Commission member Ms. Verni Howard who will be representing the financial institution. The DDD Commission welcomed Ms. Howard to the board.

**5.** Board Action – Nominating Committee – The Commission viewed, via power point, an image of the DDD logo. Each Commissioner received a copy of the proposed slate of 2012 officers. Mr. Norman Chenevert presented the slate of nominees for the 2012 officers as follows: Chris Nichols, Chairwoman; Norman Chenevert, Vice Chairman; Fran Gladden, Treasurer and, Danny Montelaro, Secretary. Transit Tax Proposal – The Commission viewed, via power point, an image of the BRTC logo. Each Commissioner received a copy the fact sheet. Ms. Lacy Strohschein reviewed the Baton Rouge Transit Coalition presentation and encouraged everyone to submit a support pledge card, visit the web site for more information and support the tax proposal on April 21, 2012. Ms. Fran Gladden recommended that the DDD Commission support CATS proposed transit tax. Mr. Van Mayhall seconded and the motion was unanimously approved.

**6b. Development Initiatives** – **North Boulevard Town Square Update (NBTS)** – The Commission viewed, via PowerPoint, photographs of North Blvd. Town Square. Each Commissioner received a copy of the newspaper article. Mr. Gabe Vicknair reported the following:

- Transit Signage Currently printing CATS transit map / LSU transit maps
- Litter getters installed on trash receptacles & pet waste dispensers installed in NBTS

Mr. Rhorer reported that the North Blvd. Town Square was recently used for the Appetite For Life event and Varsity Sports relay event.

**Repentance Park Update** – The Commission viewed, via PowerPoint, photographs of current construction. Each Commissioner received a copy of the newspaper articles. Mr. Vicknair briefed the Commission on the following time line:

- Demolition has begun / removing trees and existing wall on west side of City Hall
- 210 days for construction Completion by Sept. 3,2012

Mr. Rhorer expressed that this project will tie into Galvez Plaza and NBTS. The Shaw Center for Arts will construct a marquee entrance on North Blvd. that will also tie into the town square. Mr. Rhorer commended Mr. Justin Lemoine for his work on this project.

**Cultural District Expansion Request** – The Commission viewed, via PowerPoint, an aerial image indicating current cultural district boundaries and the proposed boundary expansion. Each Commissioner received a copy of the correspondence. Mr. Vicknair informed the Commission that the DDD has applied for a Cultural District Expansion. Currently any sales of one of a kind original art work are tax free within the Arts and Entertainment District. The expanded boundaries would include all of the DDD as well as Arts Market and Fest For All.

**FUTUREBR Implementation Team** – The Commission viewed, via PowerPoint, an image of the cover of FUTUREBR plan. Each Commissioner received a copy of the newspaper article and action items. Mr. Rhorer informed the Commission that the Zoning Advisory Committee is working on updating the zoning codes and the Implementation team is devising a series of action items based on the FUTURE BR plan.
