- 1. Mr. Derrell Cohoon called the meeting to order.
- 2. Mr. Derrell Cohoon declared a quorum.
- 3. Mr. Chenevert moved to approve the agenda, Mr. Mayhall seconded and the agenda was approved as amended.
- 4. Mr. Mayhall moved to approve the March 11, 2008 minutes, Mr. Chenevert seconded and the minutes were approved.

Mr. Norman Chenevert introduced Mr. Jaird Alvarez and Sebastian Alvarez Mr. Rhorer introduced and welcomed Mr. James Andermann, new Development Project Director for the Downtown Development District. Mr. Rhorer thanked Pierre Legrand, General Manager of the City Club, for hosting the Commission meeting.

## 5. Board Action

- 6a. **Governmental Issues** Mr. Rhorer informed the Commission of the Mayor's capital outlay requests. The projects include the expansion of the river center, downtown riverfront improvements and the children's museum.
- 6b. **Development Initiatives 2008 Mayor' Luncheon –** Mr. Rhorer informed the Commission that the DDD is planning to host the Mayor's luncheon in celebration of the Downtown Development District's 20<sup>th</sup> year of service. The luncheon is tentatively planned for May 2008.
- **Arts & Entertainment District Update** The Commission viewed, via power point, an aerial photograph of the Council approved Arts & Entertainment District. Each Commissioner received a copy of the Economic Incentive Strategic Plan RFQ (see below) and newspaper articles. Mr. Rhorer thanked everyone involved in the process to establish an Arts & Entertainment District.

**Economic RFQ** – Mr. Fluhr informed the Commission that the Request For Qualifications is completed and will be released within the next week. The following entities have partnered to provide the \$65,000 retainer to hire a consultant.

Baton Rouge Area Foundation Downtown Business Association Downtown Development District Convention and Visitors Bureau City of Baton Rouge

The consultant will create an economic incentive package for the Arts and Entertainment District and the implement the arts component.

**Policy Meeting** – Mr. Cohoon expressed that the policy issues are very important to the Arts and Entertainment District. The recent occurrences related to private parties in the downtown area can cause a negative impact on the efforts of the Arts and Entertainment District. Mr. Cohoon expressed that the committee will address this incident immediately and requested that Mr. Brace Godfrey work with him on developing a policy to address such issues. The Arts & Entertainment Committee will host a meeting on Thursday, April 17 at 5:00 p.m. for all members and stakeholders to address these issues.

North Boulevard Town Square/Riverfront Master Plan – The Commission viewed, via power point, a map indicating the location of proposed North Blvd. Town Square. Each Commissioner received a copy the newspaper article. Mr. Rhorer informed the Commission that the Design and Selection board selected Brown/Danos and Joey Furr Design Studio as the

Landscape Architects for the North Blvd Town Square. Mr. Rhorer reviewed the list of the sub consultants involved in the project.

II City Plaza – The Commission viewed, via power point, a photograph of the building under construction. Mr. Ted Terrell informed the Commission that the 12 story, 260,000 sq. ft. office building includes an adjoining 650 space parking garage and is scheduled to be completed by mid January 2009. The two major tenants are Regions and Phelps Dunbar and there is space available for a restaurant and retail. The garage will be open August 2008. Mr. Terrell commended everyone involved with the project and encouraged anyone interested in rental information to contact Gary Black at 383-0424.

**Downtown Park Site** – The Commission viewed, via power point, an aerial photograph of the proposed park and a photograph of the existing building on the site. Each Commissioner received a copy of the excerpt from Plan Baton Rouge. Mr. Rhorer informed the Commission that the park is proposed in Plan Baton Rouge as a linkage between the two downtown neighborhoods. Mr. Bill Palmer informed the Commission that the proposed park is on the corner of Convention and Seventh Streets. Richard Baker was successful in directing the General Services Administration to transfer the property over to BREC and securing \$300,000 in federal funds to develop the pocket park. BREC is in the process of obtaining bids for the demolition of the building which is targeted for August 2008.

**Shaw Center – One Eleven / Stroubes Update** – The Commission viewed, via power point, a photograph of the building under construction and a rendering of the project. Mr. Michael Lang informed the Commission that the project is underway and will consist of the following:

The proposed upscale steakhouse restaurant in the Stroube's Building / Stroube's Chophouse is going through the approval process with the city and the state. The process is expected to take approximately 45 days.

**Wayfinding Implementation** – The Commission viewed, via power point, a photograph of the ribbon cutting ceremony. Each Commissioner received a copy of the newspaper article and a poster of the kiosk. Mr. Rhorer informed the Commission that ribbon cutting ceremony was held last week and Phase I of the project is complete.

**Events** – **LASM** - The Commission viewed, via power point, a photograph of the exhibit. Ms. Carol Gikas encouraged everyone to attend the Jim Henson Fantastic World exhibit at the LASM, the exhibit will be on display through June 22, 2008.

**Louisiana State Museum** – The Commission viewed, via power point, a photograph of the flyer. Ms. Erin Rolfs informed the Commission that the Louisiana State Museum will be hosting several programs that spotlight music, art, history and science. All programs are free and open to the public.

**Foundation for Historical Louisiana** – The Commission viewed, via power point, a photograph of the logo. Mrs. Bennettt encouraged everyone to attend the lecture by Buddy Ragland about the green (LEED) movement and historic preservation. The lecture will be held on Thursday, April 10, 6:00 p.m. at the Old Governor's Mansion.

Mr. Kerry Ruiz, Event Planner, reviewed the schedule and informed the Commission that first concert commenced on Friday, March 28 was a tremendous turnout. The concerts are held at Galvez Plaza from 5:00 p.m. – 8:00 p.m.
