- **2.** Ms. Chris Nichols declared a quorum.
- 3. Mr. Norman Chenevert moved to approve the agenda, Ms. Fran Gladden seconded and the agenda was approved.

Mr. Rhorer announced that April marks the one year anniversary for the completion of North Blvd. Town Square (NBTS). The NBTS has hosted over 150 events to date.

- **5. Board Action** There was no board action.
- **6a. Governmental Issues** There was no information to report.
- **6b. Development Initiatives River Center Library** The Commission viewed, via PowerPoint, images of the concept designs. Each Commissioner received a copy of the newspaper articles. Mr. Spencer Watts, library director, informed the Commission that a community input meeting was held Wednesday, April 3 at the Louisiana Art and Science Museum. Mr. Watts reviewed the concept designs and briefed the Commission on the proposed design of the library. Ms. Mary Stein encouraged everyone to view the schematic design presentation on the EBR Library web site and submit their comments.

Repentance Park Update – The Commission viewed, via PowerPoint, photographs of the Repentance park ribbon cutting and toy box. Each Commissioner received a copy of the newspaper article. Mr. Rhorer informed the Commission that the ribbon cutting for the park was a tremendous success and commended the DDD staff for their work on the event.

IBM – The Commission viewed, via PowerPoint, an image of the proposed rendering of the IBM building. Each Commissioner received a copy of the newspaper articles. Mr. Jared Smith, Baton Rouge Area Chamber of Commerce, informed the Commission that the IBM project will be transformational for downtown and the state of Louisiana. The development located at the old Advocate site bordered by Main, North, Lafayette Street and River Rd. will produce 800 new jobs with a build out of 1,100. The partnership between public and private sources will affect the diversity and economy of the state. The permitting process for the IBM building has begun and the construction is proposed to be completed by 2015. Mr. Smith also mentioned that there is more to come for the city. Mr. Rhorer commended everyone involved in the project.

Richoux Building Acquisition – The Commission viewed, via PowerPoint, photographs of the Richoux building. Each Commissioner received a copy of the newspaper articles. Mr. Michael Crouch informed the Commission that he purchased the Richoux's building at the corner of Third Street and Florida St. Negotiations are in the works to house Raising Canes' in the first floor and preliminary plans include a restaurant on the top floor and there will be additional space available on the first floor. The building will undergo a \$1-2 million renovation. Mr. Ben B. Taylor informed the Commission that the Coca Cola sign will be repaired and working.

Commerce Building Update – The Commission viewed, via PowerPoint, an image of the proposed rendering of the Commerce building. Each Commission received a copy of the newspaper article. Mr. Rhorer informed the Commission that the project is proceeding.

Downtown Greenway Update – The Commission viewed, via PowerPoint, renderings of the proposed greenway. Each Commissioner received a copy of the newspaper articles. Ms. Whitney Cooper informed the Commission that the overall public response has been excitement for the project as well as recommendations from the consultants using the East Blvd. median for the bikeway, reconciling neighborhood concerns about parking and bike pedestrian desire for a designated path.

Expressway Park – The Commission viewed, via PowerPoint, an image of proposed greenway. Ms. Angela Harms, BREC, informed the Commission that BREC is partnering with the DDD on a portion of the Greenway that goes through Expressway Park.

The first portion of the pathway will be built within Expressway Park. In conjunction with the Greenway BREC is developing a master plan for the park. A follow up public meeting is scheduled for Thursday, May 2nd at Expressway Park.

Hampton Inn Update – The Commission viewed, via PowerPoint, a photograph of the Hampton Inn. Each Commissioner received a copy of the newspaper article. Ms. Allison Crump, Director of Sales, informed the Commission that the hotel has an anticipated opening date between April 30 – May 1 and reservations are open for individuals and groups.

BR Walls – The Commission viewed, via PowerPoint, a photograph of a mural on the back of the building located at 450 Main St. Mr. Rhorer informed the Commission that BR Walls has completed the mural on the wall located at Main and Fifth Street.

King informed the Commission that in July 2012 the Downtown Task Force was formed and has been responsible for approximately 400 arrests and assisted 30 individuals to return home.
