6a. **Governmental Issues** – **Louisiana State Historic Tax Credits** – The Commission viewed, via PowerPoint, an image of the state capitol and the legislation. Mr. Rhorer announced that he testified before the Senate Finance and Executive committee for support of the renewal of state historic tax credits on commercial properties. The legislation passed through the committee and moved to the House Ways and Means committee.

**6b. Development Initiatives – Beauregard Town** – The Commission viewed, via PowerPoint, images pertaining to Beauregard Town. Mr. Brian Goad informed the Commission that the Beauregard Town Civic Association has formed a security committee and briefed the Commission on the following:

**Tree Trimming** – The event is scheduled for Saturday, May 14, 8am and will begin at Beauregarden.

**Audio Tour** – Beauregard Town Civic Association has been working with the Louisiana State Museum, Foundation For Historical Louisiana and Frank McMains to create an audio tour for Beauregard Town. They are currently in the process of finalizing the contents.

**Beauregarden** – Mr. Goad recognized Rev. Andrews and Ms. Margaret Read for their partnership in the garden. The garden is a partnership between First United Methodist Church and Beauregard Town Civic Association (BTCA). The garden has twenty four plots and has been a great community building tool. The garden will be featured in Chef John Folses' new book. BTCA has secured the donation of three benches from Victor Stanley, Inc. Mr. Rhorer commended Mr. Goad for his work with Beauregard Town.

**Blue Ribbon Commission on Baton Rouge Transit** – The Commission viewed, via PowerPoint, an image of current newspaper article. Each Commissioner received a copy of the newspaper article and survey. Mr. Rhorer attended a recent meeting of the Blue Ribbon Commission and was extremely impressed with the research that has been done. The Blue Ribbon Commission has solicited a survey regarding transit in EBR Parish. Ms. Felder encouraged everyone to participate in the survey and rank service options and vote on one of four proposals.
