1. Ms. Chris Nichols called the meeting to order.

2. Ms. Chris Nichols declared a quorum.

3. Mr. Van Mayhall, Jr. moved to approve the agenda, Mr. Derrell Cohoon seconded and the agenda was approved.

4. Mrs. Fran Gladden moved to approve the April 9, 2013 minutes, Mr. Van Mayhall, Jr. seconded and the minutes were approved.

Mr. Rhorer thanked the Capitol Park Museum for hosting the DDD board meeting.

5. Board Action – There was no board action.

6a. Governmental Issues – Legislation items status – The Commission viewed, via PowerPoint, an image of the legislation. Each Commissioner received a copy of the legislation. Mr. Rhorer briefed the Commission on the legislative items that affect downtown and reviewed downtown achievements made possible by the tax credits such as the Hilton and Kress.

SB 208 - Extends the tax credit for the rehabilitation of historic structures and provides for the applicability of such credit.

SB 197 - Extends income tax credits for the rehabilitation of certain owner occupied residential structures.

HB 283 - Provides relative to tax credits for state-certified musical or theatrical productions and state-certified infrastructure projects

HB 630 - Provides for the transferability of the income tax credit for the rehabilitation of historic commercial structures

Mr. Rhorer thanked Mr. Derrell Cohoon for monitoring the legislation that affects downtown.

6b. Development Initiatives – **Hampton Inn Update** – The Commission viewed, via PowerPoint, photographs of the exterior and interior of the Hampton Inn. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer informed the Commission that the hotel is open and encouraged everyone to visit the facility. Mr. Rhorer will be meeting with hotel management, Hospitality America, to discuss Lafayette Street issues.

Commerce Building Update – The Commission viewed, via PowerPoint, an image of the proposed rendering of the Commerce building. Mr. Rhorer informed the Commission that the project is proceeding.

Downtown Greenway Update – The Commission viewed, via PowerPoint, renderings of the proposed greenway. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer informed the Commission that the schematic design has been approved and the consultants are making the final changes. Ms. Whitney Cooper reviewed the proposed renderings and expressed that the DDD continues to work with BREC. Davis Rhorer commended Whitney Cooper and Gabe Vicknair for their work on the \$100,000 grants for Lincoln Theater and Expressway Park. Ms. Angela Harms, BREC, informed the Commission that the public comments have been used to create the conceptual plan and they continue moving forward in partnership with DDD and the downtown Greenway Project. Mr. Van Mayhall, Jr. asked if the Wards Creek trail project would have the potential to link to the Downtown Greenway. Discussion ensued of the potential to connect. BREC is working with DOTD on additional lighting for Expressway Park at Interstate 10 and Interstate 110. The BREC public input survey will be distributed digitally to DDD email list.

Florida Street Levee Access / River Road Path – The Commission viewed, via PowerPoint, renderings of the proposed improvements. Mr. Rhorer informed the Commission that bids for the proposed \$1.1 million project will open June 22, 2013. The project will allow access to the levee at Florida and River Rd. for bikes and pedestrian and a pathway to the LASM. Susan Turner and Associates is currently in the process of designing a new plaza for LASM that will link to NBTS Phase II and Repentance Park.

Downtown Grocery – The Commission viewed, via PowerPoint, photographs of the ribbon cutting ceremony. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer informed the Commission that the ribbon cutting ceremony was well attended and commended the DDD staff for their work on this project.

Convention Street Park Sculpture– The Commission viewed, via PowerPoint, photographs of the sculptures. Each Commissioner received a copy of the newspaper article. Mr. Gabe Vicknair informed the Commission that he has been working with sculptor JoJo Jilbert to install some of his pieces in the downtown area. BREC agreed to install two of the sculptures at Convention Street Park.

Downtown Residential Checklist – The Commission viewed, via PowerPoint, a photograph of a home in Beauregard Town. Ms. Chris Nichols informed the Commission that the committee is in the process of obtaining information and will report next month. Ms. Nichols requested that anyone with utility or public work issues to contact her.

Literary Committee – The Commission viewed, via PowerPoint, a photograph of the Louisiana Book Festival. Mr. Van Mayhall, Jr. informed the Commission that this is not the first effort for Baton Rouge to become a literary city. There is a platform to build upon and the effort seems to be transmitting information that exists. The committee is working on the following initiatives:

A meeting with the Louisiana Center for the Book has been scheduled to discuss the expansion of the Louisiana Book Festival.

North Blvd. Town Square (NBTS) Anniversary – The Commission viewed, via PowerPoint, a photograph of the event held at North Blvd. Town Square (NBTS). Mr. Rhorer announced that April marks the one year anniversary for the completion of North Blvd. Town Square (NBTS). The NBTS has hosted over 150 events to date. The Commission viewed a video celebrating the 1 year anniversary of NBTS. Mr. Gabe Vicknair informed the Commission that the City of Baton Rouge has entered into a contract with MayerIT to expand the technical abilities of the beacon using specialized software.
