- **2.** Mr. Norman Chenevert declared a quorum.
- **3**. Ms. Chris Nichols moved to approve the agenda, Mr. Scott Hensgens seconded and the agenda was approved.

5. Board Action – There was no board action.

- **6a. Governmental Issues Old LNB Building Redevelopment District** The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Each Commission received a copy of newspaper article and Senate Bill. Mr. Davis Rhorer informed the Commission that the legislation cleared the chambers without amendments. The TIF bill will create a TIF district for the LNB Building to be developed into a hotel.
- **6b. Development Initiatives 440 on Third** The Commission viewed, via PowerPoint, a photograph of the exterior of the building and floor plans for the apartments. Mr. Dyke Nelson briefed the Commission on the floor plans for the apartments and informed the Commission that the renovations are 50% complete with a completion date of December 31, 2014. The grocery store is expected to be complete by September 2014.

Rotary Overlook – The Commission viewed, via PowerPoint, the presentation of the proposed project. Each Commission received a copy of the project summary and proposed rendering. Mr. Rhorer reviewed the presentation and informed the Commission that Rotary was looking for a way to commemorate their 100th anniversary in 2018. The DDD presented Rotary with a proposal to construct an overlook and sculpture on the riverfront at Florida and River Road. Rotary selected the proposal and will partner with the DDD to build the overlook and sculpture. There will be a design competition to determine the design and Rotary is in the process of raising funds. Mr. Rhorer thanked Rotary for selecting the project.

Riverfront Gateways – The Commission viewed, via PowerPoint, an aerial indicating the riverfront gateways. Mr. Rhorer briefed the Commission on the improvements that have been made to the riverfront gateways and proposed improvements.

UDC Levels – The Commission viewed, via PowerPoint, a photograph of the Each Commission received a copy of the introduction and design level requirements. Mr. Ryan Holcomb briefed the Commission on the UDC levels. Design levels are intended to provide a range of guidelines for development by promoting and encouraging consistency in the quality of design and ensure that high quality development is maintained throughout the Parish. The intent of the design levels is to require additional standards in areas desiring to increase the walkability and strengthen the physical and economic character of identified areas.

326 Third Street – The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Mr. Dyke Nelson informed the Commission that Edible Events will locate upstairs and a restaurant/ lounge will locate downstairs. The project has received tax credits and is expected to be complete by the end of 2014.

Town Square WiFi – The Commission viewed, via PowerPoint, a map indicating the areas of WiFi downtown. Each Commission received a copy of the map indicating the areas of WiFi. Mr. Gabe Vicknair informed the Commission that the DDD has partnered with the River Center's contract with Verma Systems to upgrade its wireless internet to include the installation of Wi-Fi for NBTS, Repentance Park, Riverfront Plaza and LASM. The WiFi will send users to a landing page that will provide information regarding downtown.

Downtown Greenway Update – The Commission viewed, via PowerPoint, an image of the proposed renderings. Phase II has been awarded and will coincide with Phase I construction for a total of approximately 6 months.
