1. Mr. Derrell Cohoon called the meeting to order.

2. Mr. Derrell Cohoon declared a quorum.

3. Mr. Mayhall moved to approve the agenda, Mr. Chenevert seconded and the agenda was approved as amended.

4. Ms. Nichols moved to approve the June 10, 2008 minutes, Mr. Mayhall seconded and the minutes were approved.

Mr. Rhorer recognized Ms. Mary Frey Eaton and thanked Mr. Tom Livesay for hosting the Commission meeting. Mr. Livesay briefed the Commission on the upcoming exhibits.

5. Board Action – There was no board action.

6b. **Development Initiatives – Ethics Legislation** – The Commission viewed, via power point, a photograph of the State Capitol. Each Commissioner received a copy of Act 162 and Act 472. Mr. Rhorer informed the Commission that recently enacted ethics legislation requires boards and commissions to provide financial disclosures. If an individual is sitting on a board as of July 1, 2008, he/she is subject to the legislation. The new legislation has not been fully defined and as a result there have been a number of resignations across the state. Since the new law has not been fully defined, Commissioner Brace Godfrey has elected to resign. Mr. Godfrey is the Mayor's representative. Mr. Rhorer and Mr. Cohoon will meet with the Mayor to discuss potential candidates for the position.

Plan Baton Rouge Master Plan Phase II – The Commission viewed, via power point, photographs of public presentation by the firms. Each Commissioner received a copy of newspaper articles. Mr. Rhorer informed the Commission that the committee has selected Chan Krieger Sieniewicz as the consultant team for the plan. Mr. Rex Cabanis, local planning director, reviewed the project team below:

North Boulevard Town Square – The Commission viewed, via power point, a site map indicating the location of the proposed North Blvd. Town Square and surrounding developments. Each Commissioner received a copy of the newspaper article. Mr. Rhorer informed the Commission that the consultants are in the process of gathering base data and the committee will meet with the consultants on Tuesday, August 5, 2008.

Stroube's Update – The Commission viewed, via power point, photographs of current construction and proposed renovations. Mr. Rhorer informed the Commission that the Stroube's Steakhouse is scheduled to open by the end of 2008 and the Liner Building is scheduled to be complete by September 2008.

Kress at Third and Main – The Commission viewed, via power point, a photograph of current construction, rendering of the project and the logo. Each Commissioner received a copy of newspaper article. Ms. Susannah Bing informed the Commission that the residential units will be complete in mid October 2008. One of the condominiums has a sales contract and three of the apartments are leased. Parking is available in the Manship parking lot. The anchor tenant for the Kress at Third and Main is The Little Village Fish Market and there are two letters of intent pending: (1) one for a bakery and (2) the other for women's shoe, apparel store. Cyntreniks is also working to secure a pharmacy and a specialty grocery. Mr. Rhorer thanked everyone involved in this project.

Arts & Entertainment District Update – The Commission viewed, via power point, an aerial photograph of the Council approved Arts & Entertainment District. Each Commissioner received a copy of newspaper article. Mr. Cohoon informed the Commission that the committee received preliminary reports from the sub-committees regarding the following issues:

- Coordination of reception facilities and security issues

- Traffic Control

The economic development component of Plan Baton Rouge Phase II of the Chan Krieger Sieniewicz plan will address the Arts & Entertainment District.
