- **2.** Ms. Chris Nichols declared a quorum.
- 3. Mr. Norman Chenevert moved to approve the agenda, Mr. Derrell Cohoon seconded and the agenda was approved.
- **4**. Mr. Ric Kearny moved to approve the May 14, 2013 minutes, Mr. Norman Chenevert seconded and the minutes were approved.

**5. Board Action** – There was no board action.

**6a.** Governmental Issues – Legislation items status – The Commission viewed, via PowerPoint, an image of the legislation. Each Commissioner received a copy of the newspaper article and legislation. Mr. Rhorer informed the Commission that the legislative items regarding tax credits that affect downtown remain intact. Mr. Rhorer thanked everyone involved with monitoring the legislation. There is a "Capital Park Study Committee" that will study traffic issues downtown. The committee will be meeting before September 2013 and there is a representative from DDD and Spanish Town on the committee. Mr. Derrell Cohoon informed the Commission that there are funds in Capital Outlay bill to purchase the old Insurance Building.

Mr. Rhorer informed the Commission that the Pages for Progress have been updated and the information will be distributed electronically.

**2013 Budget Supplement** – The Commission viewed, via PowerPoint, an image of the legislation. Each Commissioner received a copy of the newspaper article and correspondence. Mr. Rhorer informed the Commission the Metropolitan Council approved \$900,000 in the budget supplement for the following projects:

- Planning of Levee Bike Path Extension
  – North to connect Hollywood Casino and River Park
  Development
- City Hall Plaza Improvements
- City Dock Shade Structure –
- River Rd. Crossing Extension of Repentance Park south on River Rd. to help connect to LASM

Mr. Rhorer commended Mayor Holden and the Metropolitan Council for their support.

**6b. Development Initiatives** – **Hampton Inn Ribbon Cutting** – The Commission viewed, via PowerPoint, a photograph of the exterior of the Hampton Inn. Mr. Rhorer informed the Commission that the ribbon cutting has been scheduled for Thursday, August 1 at 11:00 a.m.

**Capital One Building**– The Commission viewed, via PowerPoint, a photograph of the exterior of the building. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer informed the Commission that Mr. Dyke Nelson and Mr. David Weinstein purchased the building at 440 Third St. Plans for the building is mixed use development.

**302 Third Street Update** – The Commission viewed, via PowerPoint, photographs of the exterior of the building. Each Commissioner received a copy of the newspaper article. Mr. Chris Ferrari, architect, informed the Commission that they are in the early stages of redevelopment of bldg. They have submitted the first phase for historic tax credit process. There is a potential tenant for 1<sup>st</sup> floor and 2<sup>nd</sup> tenant for ground floor is proposed fast casual restaurant. Improvements include façade renovations, proposed roof top open beer garden and screen on back of coca cola sign Mr. Rhorer complemented on using the roof top. Work is expected to commence by the end of the year.

**Third Street Development** - The Commission viewed, via PowerPoint, an image of the map indicating development along Third Street. Mr. Rhorer reviewed the growth of diversity of development along Third Street.

**Commerce Building Update** – The Commission viewed, via PowerPoint, photographs of the exterior of the building and images of the renderings for the Commerce building. Mr. Rhorer informed the Commission that the project is utilizing the state historic tax credits and project is proceeding.

**Downtown Greenway Update** – The Commission viewed, via PowerPoint, images of the survey results. Each Commissioner received a copy of the newspaper articles. Ms. Whitney Cooper informed the Commission that the BREC public input survey was distributed digitally to DDD email list and over 400 responses were received. Ms. Cooper reviewed the responses with the Commission.

Florida Street Levee Access / River Road Path – The Commission viewed, via PowerPoint, renderings of the proposed improvements. Mr. Rhorer informed the Commission that DOTD accepted the low bid of \$1.2 million for the proposed street scape improvements at Florida and River Rd. The next step will go through regulatory approval process of the Metropolitan Council in August and construction should commence September 2013. The project will allow access to the levee at Florida and River Rd. for bikes and pedestrians and a pathway to the LASM.

**LASM Urban Plaza** – The Commission viewed, via PowerPoint, renderings of the proposed improvements. Mr. Brian Goad, Suzanne Turner Associates, briefed the Commission on the proposed improvements north of the LASM building. The plaza is envisioned as a gathering space to be used by the public that will link to North Blvd. Town Square Phase II and Repentance Park. Schematic designs have been submitted to the City and the next phase is design development

**Downtown Residential Checklist** – The Commission viewed, via PowerPoint, a photograph of residential in Central Business District. Ms. Whitney Cooper informed the Commission that the committee has met and defined the issues and identified the agencies that would rectify the issues. Following are the issued identified by the committee:

- Mail delivery
- Recycling
- Trash pick up
- Building permitting process
- Overall agency coordination between Entergy, DPW, and Water Company
- Unused utility / signage removal
- Street closure notification
- Sidewalk, road, tree well maintenance

The committee will meet again in August 2013.

Mr. Rhorer informed the Commission that the East Baton Rouge Mortgage Finance Authority (EBRMFA) gave the DDD approval for planning funds for the Greenway which has been approved by the Metropolitan Council. The appropriation of the funds will be presented to the Metropolitan Council for their approval. Mr. Rhorer commended Mr. Norman Chenevert for his assistance as well as the Metropolitan Council and EBRMFA for their support. The DDD is also identifying where development sites can be along the greenway.

**Design Resource Center (DRC)** – The Commission viewed, via PowerPoint, photographs of the reception. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer informed the Commission that the DRC held their Ribbon Cutting and recognition of the sponsors and the young entrepreneurs.

**New Business** – The Commission viewed, via PowerPoint, a photograph of the Capital One invitation. **Capitol One** – Ms. Ashanti Green informed the Commission that Capitol One Bank has moved to 301 Main Street in One American Place. Mr. Kearny informed the Commission that Capital One is occupying three floors in One American Place.

The offices are located at 611 North Street.
