- Fr. Pat Mascarella shared a few words of wisdom. Mr. Davis Rhorer thanked The City Club for hosting the meeting and introduced City Club manager, Mr. Pierre LeGrand. Mr. LeGrand welcomed everyone to The City Club.

6b. Development Initiatives – **Downtown Greenway Update** – The Commission viewed, via PowerPoint, a rendering of the proposed greenway. Mr. Rhorer informed the Commission that there will be an announcement tomorrow, Wednesday, September 12, 2012 regarding funding for the Greenway. Mr. Rhorer commended everyone involved with this recent proposal submission.

Galvez Plaza Stage Canopy Update – The Commission viewed, via PowerPoint, renderings of the proposed riverfront improvements Mr. Rhorer informed the Commission that the canopy is currently under construction in Kansas City, Missouri. Mr. Rhorer and other members of the project development team will make a site visit to view the construction of the stage canopy.

Florida Street and River Rd. Levee Access / LASM Improvements – The Commission viewed, via PowerPoint, an aerial image indicating the area for improvements and proposed renderings. Mr. Rhorer informed the Commission that Department of Public Work is waiting on the finalization of the CORPS of Engineers approval and Canadian National Railroad approval on the project and that the construction plans were submitted to DOTD. These improvements are a direct recommendation from PBR II.

Repentance Park Update – The Commission viewed, via PowerPoint, a photograph of the current construction site. Mr. Gabe Vicknair briefed the Commission on the construction progress and informed the Commission that the project remains on schedule for the completion date of November 2012.

Commerce Building Update – The Commission viewed, via PowerPoint, a 1955 photograph of the Commerce building. Mr. Michael Lang informed the Commission that he will be serving as the representative of the 5th floor Company and private investors that recently purchased the Commerce building. The Commerce building was built in 1955 and Mr. Lang encouraged anyone that may have stories or pictures of the building to make those available. A community charette is scheduled for Thursday, November 1, 2012 to gather feedback on the project. Mr. Lang commended everyone involved with the project. Mr. Rhorer announced that the charette will be held in the Design Resource Center of the new DDD offices at 247 Florida St.

Spanish Town Investment – The Commission viewed, via PowerPoint, photographs of the residential properties. Mr. Rhorer informed the Commission that there have been 13 properties acquired in Spanish Town that will be renovated. Mr. Ben Babin, Spanish Town resident, informed the Commission that he and Mr. Lance Bennett have purchased five properties in Spanish Town and are in the process of renovating them. The renovations are projected to be complete by November 2012 and will be available for rent. Mr. Rhorer commended Mr. Babin on his investment in downtown Baton Rouge.

Downtown Grocery Store Survey – The Commission viewed, via PowerPoint, a photograph of the survey. Mr. Gabe Vicknair informed the Commission that the survey received 1200 respondents and reviewed the survey results. The DDD is proposing to commission a market study for a grocery store. Mr. Rhorer expressed that a downtown grocery store was recommended in PBR II.

BR Walls Project – **Wall #2** – Mr. Rhorer informed the Commission that BR Walls has begun the second project at Harrington's Café, 329 Florida Street.

Mr. Trey Godfrey informed the Commission that Springboard in partnership with Vision City Development Group is announcing the formation of Capitol Region Venture Partners, which will be a Venture Capitol Group. A luncheon is scheduled for Friday, September 14, 12noon at the Kress Gallery to officially unveil the venture. The venture fund is being established with \$5 million founding member subscription, more than \$1 million has already been subscribed. The principal purpose of raising \$5 million is for seed capitol for initial funding for these entrepreneur start ups as well as seed capitol and initial funds for several real estate projects. Springboard will unveil the 4 companies that will start into the Springboard entrepreneur accelerator program in the fall 2012 and introduce three potential real estate development projects in and around downtown. The future speaker at the luncheon is James Digby, expert in entrepreneurship and startup facilitator.
