1. Mr. Van Mayhall called the meeting to order.

2. Mr. Van Mayhall declared a quorum.

3. Mr. Cohoon moved to approve the agenda, Mr. Chenevert seconded and the agenda was approved.

4. Mr. Chenevert moved to approve the September 14, 2010 minutes, Mr. Cohoon seconded and the minutes were approved.

Mr. Rhorer thanked Mr. Tom Livesay for hosting the October DDD Commission meeting at the LSU Museum of Art. Mr. Livesay welcomed everyone to the museum and encouraged them to view the exhibit following the meeting.

5. Board Action – There was no board action.

6a. **Governmental Issues** – **DDD Tax Renewal** – The Commission viewed, via Power Point, a collage of images of past newspaper articles feature downtown developments. Mr. Rhorer informed the Commission that the DDD tax renewal passed with a 77% approval rating, the renewal tax begins in 2012. Mr. Rhorer thanked the board and stakeholders for their support and briefed the Commission on the 2010 awards that the DDD has been presented.

**Public Safety Issues** – The Commission viewed, via Power Point, a photograph of City Police vehicle. Mr. Rhorer introduced Lt. Carl Dabadie, Baton Rouge City Police. Lt. Dabadie expressed that the City Police has increased their efforts in public safety in addition to the current patrolling. Mr. Chenevert announced that the contract for the police storefront space on Third Street has been completed. Construction is anticipated to begin within 30 days and should be complete near the year's end. Mr. Rhorer announced that the DDD has met with downtown stakeholders and Beauregard Town Civic Association (BTCA) regarding security issues and complemented BTCA for their efforts.

**6b. Development Initiatives – Brace Godfrey Recognition** – The Commission viewed, via Power Point, photographs of Brace Godfrey, Kress building, Cyntreniks building and commemorative table. Ms. Copper Alvarez informed the Commission that a table top was created in honor of Brace Godfrey and designed representing his beliefs. Donations were also collected in his honor and were dedicated to the youth project programs and youth outreach efforts that Mr. Godfrey supported. Ms. Alvarez thanked the donors and everyone involved with the project.

**DDD 2011 Budget / Strategic Plan** – The Commission viewed, via Power Point, an image of the DDD logo and proposed renderings of current projects. Each Commissioner received a copy of the proposed 2011 budget, Goals and Objectives and strategies.

Mr. Van Mayhall informed the Commission that the strategic goals document consists of long range goals to be considered over the next few years and there will be a presentation at the November board meeting. Mr. Mayhall requested the Commission review the information and contact the DDD office with any comments or suggestions.

**Main Street Developments** – The Commission viewed, via Power Point, aerial photographs indicating the location of the each proposed Main Street development, as well as renderings of each project. Each Commissioner received a copy of the newspaper articles. Mr. Richard Preis briefed the Commission on the transactions that will take place for the proposed development. Mr. Preis will be partnering with a South Carolina firm to construct a Hampton Inn & Suites on the corner of Main and Lafayette Street. Currently the hotel will have approximately 150 rooms and 150 parking spaces have been secured in the LaSalle parking garage. Financing is secure and construction is scheduled to commence in late spring 2011. Mr. Preis will also continue to pursue residential development projects in the downtown area.

**438 Main Street** – The Commission viewed, via Power Point, aerial photographs indicating the location of the proposed residential development. Mrs. Helena Cunningham informed the Commission that she and her husband Kevin Cunningham have partnered with Norman Chenevert Development Company, Chenevert Architects and Liberty Bank & Trust to purchase the building at 438 Main Street. The building will be converted into a 22 residential unit development consisting of 16 one-bedroom and six two-bedroom units. Three of the units will be secured for low income residents. The project has been awarded a state grant and will be a mixed-income development. The anticipated closing date is January 2011 and construction is expected to commence soon thereafter with a 12 month construction period. Mr. Chenevert congratulated the Cunningham's for their success in securing the funds. Discussions are underway regarding the use of the Galvez Parking garage for residential parking.

**River Center Library** – The Commission viewed, via Power Point, photographs of libraries throughout the country. Each Commissioner received a copy of the newspaper articles. Mr. David Farrar informed the Commission that the library board of control voted to build a new library building downtown. The board is presently gathering information for drafting the scope of services, the information will be submitted to DPW and architectural services. The Metropolitan Council will vote on the item in December 2010. Mr. Farrar thanked everyone involved in the downtown library efforts.

**324, 326, 334 Third Street Properties** –The Commission viewed, via PowerPoint, a photograph of the exterior of the properties, a listing of available incentives for Third St. properties and an event flyer. Each Commissioner received a copy of the newspaper article. Mr. Rhorer informed the Commission that the Moyse and Simmons family are taking bids on the properties through Oct. 15, 2010. On Tuesday, Oct. 12 at 12noon the Foundation for Historical Louisiana with the Louisiana Division of Historic Preservation is hosting a luncheon that will take a close look at the potential of the Third Street buildings offered for sale by Baton Rouge Realty Company. Join them as they explore the history of the buildings (one the home of Latil's for 75 years), architecturally appropriate facade designs, and those ever important State and Federal historic tax credits available to the potential developer.

**DDD Projects Update** – The Commission viewed, via PowerPoint, a photograph of the proposed North Blvd. Town Square (NBTS) Repentance Park and flower pots. Mr. James Andermann briefed the Commission on the following projects:

**NBTS** – Joint Venture team presented 75% construction documents in September 2010 and 100% CD's are due October 18, 2010. Construction bidding will take place on October 29,2010.

**Repentance Park** – City of Baton Rouge selected Reed Hilderbrand for the consultants of Repentance Park. The DDD is in the process of drafting documents for the scope of work and will begin negotiations to execute the final contract.

**Downtown Beautification** – The Downtown Business Association, Downtown Development District, Department of Public Works & Keep Baton Rouge Beautiful have joined together to create *30 on the 30th* - Oversized Flower Pot Plantings in the Downtown area. On October 30, volunteers will plant greenery in the thirty flower pots that are located throughout the downtown area. Mr. Robert Poole, Hilton, informed the Commission that he is excited to be a part of this project and thanked the sponsorships involved.

**New Downtown Businesses** – The Commission viewed, via Power Point, a photograph of the exterior of the buildings. **Sadaf Café** – Greek and Lebanese restaurant located at 321 North Blvd. is scheduled to open in November.

Lake Quick Care – Scheduled to open Oct. 19<sup>th</sup> and operating hours are Monday – Friday 8am – 6pm.

Mr. Van Mayhall introduced and welcomed new commissioner, Mr. Danny Montelaro, president of Regions Bank.
