- 1. Mr. Norman Chenevert called the meeting to order.
- 2. Mr. Norman Chenevert declared a quorum.
- **3**. Mr. Derrell Cohoon moved to approve the agenda, Ms. Fran Gladden seconded and the agenda was approved.
- **4**. Mr. Ric Kearny moved to approve the September 9, 2014 minutes, Mr. Scott Hensgens seconded and the minutes were approved.

Rev. David Melville shared a few words of wisdom. Mr. Rhorer thanked Mr. Bill Stark, Capitol Park Museum, for hosting the meeting and encouraged everyone to visit the museum following the meeting.

5. Board Action – There was no board action.

6a. Governmental Issues – **2015 Budget** – The Commission viewed, via PowerPoint, an image of the budget and performance measures. Each Commissioner received a copy of the proposed 2015 budget and performance measures. Mr. Rhorer informed the Commission that the proposed budget for 2015 is \$641,150 and that the DDD continues to implement the performance measures. Mr. Rhorer briefed the Commission on the current and upcoming projects. Mr. Rhorer requested the Commission review the information and take action on the 2015 budget during the November 2014 Commission meeting.

6b. Development Initiatives – **Downtown Parking Study** – The Commission viewed, via PowerPoint, a photograph of the State Parking Garage. Mr. Rhorer informed the Commission the first draft will be submitted by the end of this week. The study will be completed by the end of November 2014. Mr. Rhorer announced that the State Parking Garage at Third and Convention is now open 24 hours a day seven days a week.

IBM Smarter Cities Challenge – The Commission viewed, via PowerPoint, an image of the logo. Mr. Rhorer informed the Commission that Baton Rouge was the recipient of the IBM's Smarter Cities Challenge grant. The international team has been in Baton Rouge looking at transportation issues in downtown and parish wide. The team will make recommendations at the October 17th public meeting.

Development Announcement – The Commission viewed, via PowerPoint, a proposed rendering of the exterior of the building and a photograph of the Press Conference that was held Monday, October 14, 2014. Each Commissioner received a copy of the newspaper articles. Mr. Rhorer informed the Commission that Windsor Aughtry Co. will develop a Courtyard Marriott on the corner of Florida and Third Streets. Construction on the eight floor, 147 room hotel is scheduled to commence by May 2015, with a 24 month construction period.

Onyx Development Groundbreaking – The Commission viewed, via PowerPoint, a photograph of the ground breaking, proposed rendering of the exterior of the building and the current site. Mr. Rhorer informed the Commission that the ground breaking for the Onyx Residences was held Monday, September 15 at 10:00 a.m. The 5 story mixed used building located at Convention and Third Streets will include 28 one and two bedroom apartments as well as 5,600 sq. ft. of retail on the 1st floor. Mr. Rhorer commended everyone involved with the project.

Riverfront Gateways / River Road Improvements – The Commission viewed, via PowerPoint, images of the before and after of the proposed improvements in front of LASM, Repentance Park and Florida Street & River Rd. Mr. Rhorer briefed the Commission on the current improvements that have been made to the riverfront gateways and River Road:

- River Road pathway has been formed and is in the process of being laid, street lights are being installed
- As part of the Rotary 100th year celebration the DDD is partnering with the Rotary Club to construct a public sculpture on the improved riverfront
- LASM Improvements along the north side of plaza bids open September 30, 2014

Mr. Brian Goad briefed the Commission on the LASM improvements and informed the Commission that the low bid has been accepted by the Metropolitan Council. Construction is scheduled to commence January 2015.

Downtown Maintenance Committee – The Commission viewed, via PowerPoint, a photograph of beautification initiatives. Mr. Rhorer informed the Commission that the Downtown Maintenance Committee will meet Thursday, October 16, 2014 in the Design Resource Center. The committee will appoint subcommittees to address several issues.

Town Square Update – The Commission viewed, via PowerPoint, photographs of the recent events held at Town Square. Mr. Casey Tate informed the Commission that the Town Square continues to host several events this fall. Over the next two weeks the space will be undergoing seasonal lawn maintenance.

Downtown Greenway Update – The Commission viewed, via PowerPoint, photographs of improvements to Expressway Park and Greenway proposed renderings. Ms. Whitney Cooper informed the Commission that the form work has been completed and crews are in the process of pouring the concrete for the greenway at Expressway Park. Ms. Angela Harms informed the Commission that the project has been delayed by approximately one month due to the inclement weather. Design Workshop has been hired for the construction of Phase II. There will be an eight month design process with construction to begin by the end of 2015.

New Business – Spotter's – The Commission viewed, via PowerPoint, an image of the logo. Mr. Doug Secrest informed the Commission that he is rebranding his three Fit-Blendz restaurants and will be opening another location downtown. The establishment will serve wraps, smoothies, sandwiches, salads and offer vitamins and nutrition supplements. The downtown location will be in the LaSalle Parking garage and plans are to open by November 15, 2014.

Christ in the City – The Commission viewed, via PowerPoint, an image of the logo. Rev. David Melville informed the Commission that he has opened a storefront ministry at 320 Third Street. The ribbon cutting is scheduled for Wednesday, October 15, 2014 at 10:00 a.m. everyone was encouraged to visit the ministry.

Creative Bloc – The Commission viewed, via PowerPoint, an image of the logo and a photograph of the interior of the business. Mr. John Jackson, owner, informed the Commission that the building located at 804 Main Street is a collaborative work space for visual media and creative professionals. Mr. Jackson reviewed the list of current tenants and informed the Commission that memberships will also be available for those who don't need a full time office. The business will open November 2014

Jolie Pearl – The Commission viewed, via PowerPoint, an image of the logo. Mr. Derek Fitch informed the Commission that he is a business partner of Jolie Pearl. The restaurant is located in a unique space at 315 North Blvd. and will feature 95% oysters and other menu items. Plans are to open Friday, October 24, 2014.
